

• Mediterranean characteristics:

Specific Profile of water users : Irrigation

• Definition of drought:

Not homogeneous but common understanding

 Various; both on Supply and Demand; implemented at diferent scales (local, national, regonial)

- Preparation of a more detailed proposal for **December** Return








MDGs

- Halve, by the year 2015, the proportion of people who do not have access to basic sanitation
- Develop integrated water resources management and efficiency plans by 2005 Return
